IMPORTANT NOTICE: Data is compiled from the official APOC database, which may contain uncorrected errors in candidate filings.

Contributions not kept by the candidate but rather turned over to APOC (such as from a Corporation or unidentified cash) have been excluded.

- (1) Candidates personal money, interest on bank balances, and balance from prior campaigns.
- (2) Individual contributors on APOC filings listed as employees of municipality, Anchorage school district, or of labor unions representing government employees.
- (3) Labor Unions representing Anchorage public employees (municipality, school district) or Davis-Bacon employees of local government contractors.
- (4) Examples: Alaska Blue Green Alliance, Plumbers & Pipefitters Local 375 (Fairbanks), UNITE HERE (food/hotel).
- (5) Examples: Alaska Conservation Voters; Alaska Women's Political Caucus; Citizens for Competition (telecom); ACS.
- (6) Individual contributors whose employers were not identified as MOA, ASD, or a labor union representing public employees.
- (7) Businesses group - Citizens for Adam Trombley \$50,088 spent - \$32,395 collected [67% from Anchorage Homebuilders (directly or related individuals); 15% from Dean Weidner (Apartment owner); 15% from Ron Duncan (GCI); 3% other].
